

# How to Report CPE for CHIAP® Recertification

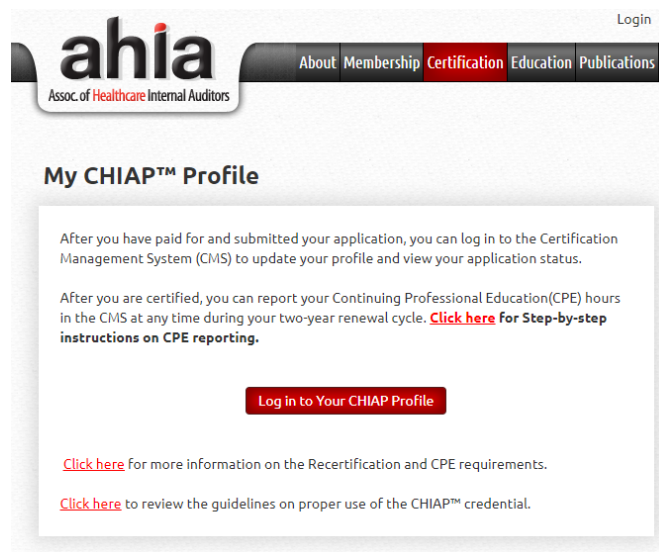
Before you begin, have you...

## 1.) Log into your CHIAP Profile in the Certification Management System (CMS)

Visit <https://ahia.org/my-chiap-profile/> and click the 'Log into Your CHIAP Profile' button.



## 2.) Click on the 'Report CPEs' link under the Recertification section in your Account Overview.
